All capitalized terms not otherwise defined in this Membership Agreement (“Agreement”) shall be defined as set forth in the Articles of Incorporation, Bylaws and IPR Policy of the HomeGrid Forum ("Organizational Documents"). Copies of the current Organizational Documents are available from Executive Director Jen Greshle (administration@homegridforum.org).

By the signature of its authorized representative below, \_\_\_\_\_ [name of prospective Member] ("Applicant"), including its Affiliates (as defined in the Bylaws), agrees to be bound by the terms hereof, as well as the terms and conditions stated in the Organizational Documents as may apply to the Promoter/Contributor/Adopter membership classification. Applicant acknowledges and agrees that all or any part of the Organizational Documents may be revised or amended, pursuant to their terms, at any time and Applicant will be bound to all such revised terms. By signing below, the individual executing this Agreement on behalf of Applicant warrants that he or she has all requisite signing authority for and on behalf of the entity seeking membership.

This Agreement is not binding on the HomeGrid Forum until (i) HomeGrid Forum actually receives the initial membership fee noted above (unless such fee is deferred at the discretion of the Board of Directors); (ii) if the Applicant is applying to join as a Promoter, this application is approved by a Supermajority vote of HomeGrid Forum’s Board of Directors; and (iii) this Agreement is executed on behalf of HomeGrid Forum by an authorized representative of HomeGrid Forum.

The term of membership shall be on a year-to-year basis, expiring on the 365<sup>th</sup> day from the date of acceptance of this Agreement by HomeGrid Forum. The HomeGrid Forum will invoice the then-current renewal fee to Members ninety (90) days prior to the expiration of the pending term and Member’s payment thereof shall constitute a renewal of membership as a Member. Failure to make a timely renewal payment shall be cause for suspension and termination of membership and member benefits.

The undersigned agrees that once accepted, all membership fees are nonrefundable for any reason, including termination of membership. There is no duty to renew any membership and renewal may only be accomplished as set forth above.

Any claim or dispute arising under or relating to this Agreement shall be governed by the internal substantive laws of the State of Oregon, without regard to principles of conflict of laws.
